Roofs: As per Mike Arnone – close to completion, only 4 gutter issues to be resolved.

NEW BUSINESS:

Violation protocol (i.e., parking, non-approved architectural and landscaping, etc. Example: parking violation:

- letter sent to homeowner to notify of violation
- -2^{nd} letter sent if no response to the first letter
- -3^{rd} letter will be sent as a reminder to rectify the issue
- a fine will be issued to homeowner if still in violation
- lastly vehicle will be towed at owner's expense

Community Beautification:

Lisa Scrivano has presented proposals to the Board for approval of having professional lighting installed at our front entrance and the flagpole area. Our CG resident, Anthony Collegio, has done all the research and arranged for numerous lighting companies to give us bids for the job. After reviewing bids, the company chosen is

Randy's Holiday Lighting as they were the most reasonable and come with excellent reviews.

The two monument walls and all the robellini palms in front of them will be lit up with warm LED lights as well as all the robellini palms in front of the flagpole area.

The total cost is \$1894. This work will be funded from our Capital Contribution Account.

Lisa Scrivano motioned to approve this enhancement for our community. Pat Carta 2nd. All in favor.

Power washing of drains and curbs:

DELEGATES MEETING HIGHLIGHTS • FEBRUARY 21, 2024 • CORAL LAKES

HOST COMMUNITY WELCOME & BREAKFAST SPONSOR – CORAL LAKES

• Bernie Dombrowsky, COBWRA Delegate, Coral Lakes President Jerry Roman, and Property Manager Laurel Kadouri, welcomed all to the community.

BREAKFAST SPONSOR

 President Wallace introduced William Campbell III, Partner at Campbell Property Management, who explained that the company manages 400 communities and has 1000 employees. He thanked the delegates for volunteering in the community. Ashley Dietz Gray, VP of Marketing and Hakari Ally were also in attendance to answer questions.

FIRST RESPONDERS' REPORTS

PBSO MAJOR CHRIS KEANE

- PBSO'S "Operation Hot Wheels" has resulted in 30 arrests and 60 vehicles impounded during efforts to reign in drag racing on local streets.
- The Citizen's Police Academy is being held every Tuesday evening beginning March 12 and ending April 23, 2024, at the District 6 Substation. Attendance is limited to the first 30 people to apply. If you are interested, contact Deputy Jason Coker at 954-553-3589.

TONY KEELER – PBC FIRE RESCUE

- Reported that 3,500 calls were responded to last month in Battalion 4, which was the highest in the County. 2,200 calls were reported in the next highest battalion.
- New station #49 on Lyons and Flavor Pict Roads is still working off generators. They are working with FPL to have power hooked up. Station #40, on White Feather Trail is now fully functional.
- Thanked COBWRA delegates for supporting PBC Fire Rescue, which in turn has allowed them to have more trucks and other resources available to residents.

GROWTH MANAGEMENT COMMITTEE - BARBARA ROTH

 The Boynton Place MUPD, located on Boynton Beach Blvd, between the Main Street shopping center and the Country Fair community, was presented. It had been previously voted on by COBWRA in June 2023. Changes to the previous plan included reducing the zoning change from Commercial High to Commercial Low, reduced self-storage from 250,000 sq. ft. to 200,000 sq. ft., increased berm to 3.5 ft and 11.5 ft of opaque screening on the north/east sides. Delegates voted unanimously to recommend denial of the application based on density, compatibility, esthetics, traffic, noise and insufficient communication with the shopping center west of the site.

SCHOOL DISTRICT REPORT-STEVE WALLACE FOR SUPERINTENDENT MIKE BURKE

The graduation rate for the School District leads the large urban school districts in Florida and exceeds the state average. The graduation rate increased from 92.8% to 94.1% for District-operated schools and 3.4% over five years.
The "Here Comes the Bus" website and app are now available at all District schools. It allows parents and guardians to receive notifications on a smartphone, tablet, or personal computer when their student's bus is arriving.
On Feb. 1, the District hosted a dedication ceremony for West Boynton Middle School. The event featured student performances and interactive presentations about the school's career programs and modern technology. One of the new innovative courses teaches students to invest in the stock market and erase debts and has a live stock market ticker in the classroom.

 Announced that due to business and personal events he will not seek a 3rd term as COBWRA president. He reflected with pride on the many COBWRA accomplishments during his two years in office. He will remain active as the Immediate Past President and Government Affairs Chair.

- As there were no nominations from the floor, the slate of officers will be elected by acclamation at the March Delegates meeting and installed at the April meeting.
